## AKTA BANTUAN GUAMAN 1971

### PERATURAN-PERATURAN BANTUAN GUAMAN (KRITERIA DAN UJIAN KEMAMPUAN) (PINDAAN) 2022

PADA menjalankan kuasa yang diberikan oleh seksyen 32 Akta Bantuan Guaman 1971 [Akta 26], Menteri membuat peraturan-peraturan yang berikut:

#### **Nama dan permulaan kuat kuasa**

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Bantuan Guaman (Kriteria dan Ujian Kemampuan) (Pindaan) 2022.**

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 7 September 2022.

#### **Pindaan peraturan 3**

2. Peraturan-Peraturan Bantuan Guaman 2017 [P.U. (A) 370/2017], yang disebut “Peraturan-Peraturan ibu” dalam Peraturan-Peraturan ini, dipinda dalam peraturan 3—

(a) dalam perenggan (b), dengan menggantikan perkataan “di bawah perenggan 4(4)(b) hingga (f)” dengan perkataan “di bawah perenggan 4(4)(b) hingga (e)”; dan

(b) dengan memasukkan selepas perenggan (b), perenggan yang berikut:

“(ba) bagi seksyen 16A Akta, orang itu lulus ujian kemampuan yang dijalankan ke atasnya dan dikategorikan di bawah perenggan 4(4)(f);”.

#### **Pindaan peraturan 4**

3. Perenggan 4(4)(e) Peraturan-Peraturan ibu dipinda, dalam teks bahasa Inggeris, dengan menggantikan perkataan “RM50,00” dengan perkataan “RM50,000”.

**Penggantian Jadual**

4. Peraturan-Peraturan ibu dipinda dengan menggantikan Jadual dengan jadual yang berikut:

LEGAL AID ACT 1971

LEGAL AID (CRITERIA AND MEANS TEST)  
(AMENDMENT) REGULATIONS 2022

IN exercise of the powers conferred by section 32 of the Legal Aid Act 1971 [*Act 26*],  
the Minister makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Legal Aid (Criteria and Means Test) (Amendment) Regulations 2022**.

(2) These Regulations come into operation on 7 September 2022.

**Amendment of regulation 3**

2. The Legal Aid (Criteria and Means Test) Regulations 2017 [P.U. (A) 370/2017], which are referred to as the “principal Regulations” in these Regulations, are amended in regulation 3—

(a) in paragraph (b), by substituting for the words “under paragraphs 4(4)(b) to (f)” the words “under paragraphs 4(4)(b) to (e)”; and

(b) by inserting after paragraph (b), the following paragraph:

“(ba) for section 16A of the Act, the person has passed the means test conducted on him and has been categorized under paragraph 4(4)(f);”.

**Amendment of regulation 4**

3. Paragraph 4(4)(e) of the principal Regulations is amended, in the English language text, by substituting for the words “RM50,00” the words “RM50,000”.

**Substitution of Schedule**

4. The principal Regulations are amended by substituting for the Schedule the following schedule:
