LEGAL AID AND ADVICE (AMENDMENT) REGULATIONS 2016

IN exercise of the powers conferred by section 32 of the Legal Aid Act 1971 [Act 26], the Minister makes the following regulations:

Citation

1. These regulations may be cited as the **Legal Aid and Advice (Amendment) Regulations 2016**.

Substitution of Second Schedule

2. The Legal Aid and Advice Regulations 1970 [P.U. (A) 299/1970] are amended by substituting for the Second Schedule the following Schedule:
